C.L.H. Hahn, with Native Affairs Ovamboland, made officer in charge of the Angola Boer Trek, + July 1928.

Stationed at Tshimhaka.

Police at Tsimhaka helped with technicalities - forwarding money, distribution, supplies, fixing the road etc.

In January 1929 (+ 29.1.1929) Hahn left for Windhoek, was called away by telegram.

In a letter from Hahn, dated 29.1.1929 Hahn asks the Police Post Commander at Tshimhaka, Hillebrand to be acting o/c of the Angola Trek.

Hahn must have returned March or April.
