Introduction

The whole HRK collection is arranged and well packaged in archival boxes in June 2024. The files are in good condition, and consist of 4 storage units. The entire collection is indexed on the Archival Files Database.

Jurisdiction in the German-South West African protectorate was exercised by the State Commissioner himself until 1890. In August 1890, a first-instance court authority was established in Otjimbingwe, which was relocated to Windhoek shortly thereafter.

This judicial district, which covered the entire protected area, was divided into two judicial districts in 1894: a northern one with the seat of office in Windhoek, and a southern one with the seat of office in Keetmanshoop. Three further judicial districts were later formed: Otjimbingwe 18954; (moved to Swakopmund in 1897/1898; Lüderitzbucht 19066 and Omaruru 1909.

In addition to their criminal and civil jurisdiction, the district courts were also responsible for maintaining the commercial registers since 1896. The activities of the district courts ended with the takeover of the German protectorate by the British forces in July 1915.

The files

According to the Commercial Code, companies and sole traders were obliged to register in the commercial register at the responsible district courts. At the district courts, the commercial register files were divided into two Departments. Sole proprietorships, general partnerships and limited partnerships were registered in Department A, identified by the reference HRA. Joint-stock companies, limited partnerships, limited liability companies and trading legal entities were registered in Department B, identified by the reference HRB. When arranging these files, these departments were retained. The HRA files are listed first, in order of appearance. The HRB files follow.
