Introduction

The whole HRL collection is arranged and well packaged in archival boxes in June 2024. The files are in good condition, and consist of 15 storage units. The entire collection is indexed on the Archival Files Database.

Jurisdiction in the German-Southwest African protected area was exercised by the state commissioner himself until 1890. In August 1890, a first instance judicial authority was set up in Otjimbingwe, which was shortly afterwards moved to Windhoek. This judicial district, which encompasses the entire protected area, was divided into two judicial districts in 1894: a northern one with the official seat in Windhoek and a southern one with the official seat in Keetmanshoop. Further judicial districts were formed later Otjimbingwe 1895); (moved to Swakopmund in 1897/1898); Lüderitz Bay 19066 and Omaruru 1909. In addition to their criminal and civil court activities. Since 1896, district courts have also been responsible for keeping commercial registers responsible. The activity of the district courts ended with the takeover of the German protected area by the English armed forces in July 1915.

The files

According to the Commercial Act, companies and sole traders were obliged to register in the commercial register with the responsible district courts. At the district courts, the commercial register files were divided into two departments. In department A, marked by the file number HRA, the companies of sole traders, general partnerships and limited partnerships were registered. Stock corporations, limited partnerships on shares, limited liability companies and trading legal entities were registered in Division B, identified by the file number HRB.
