### Introduction

The Assistant Provost Marshal at Keetmanshoop was the head of the British-South African Military Police in the District and had judiciary powers, including cases against civilians, under military law during the initial phase of South African occupation of Namibia during World War I, in 1915.

Insofar, this fonds is functionally preceded by the fonds GKE (Kaiserliches Bezirksgericht Keetmanshoop) and continued by the fonds LKE (Magistrate Keetmanshoop).

Apart from court cases and correspondence, it also contains patrol reports from the military police that highlight the general situation in the area.

The fonds consists of three storage units with mostly loose papers, and one bound record book (UA13) which in its first part contains a German police register on the arrival of Whites, 1907-1914, and was subsequently re-used for a register of "Natives".

The preservation condition of the loose papers is generally poor, but without apparent text loss.

Individual files are recorded in the database FILES, which served to re-design this finding aid.
