Introduction

A. Historical Background

The German administration of South West Africa ended on 9 July 1915 with the signing of the treaty of Khorab¹. The country was placed under martial law which remained in force until 1920 when Proclamation 76 of 1920 brought the system of martial law to an end.² In 1919, before the League of Nations mandate system had come into being, the Union of South Africa passed Act 49 of 1919, the Treaty of Peace and South West Africa Act.³ Section two of the Act made provision for the South African Governor-General to make and repeal laws in South West Africa. This duty could be and was delegated to an appointed Administrator.

In terms of the Treaty of Versailles, South West Africa became a Class "C" mandate of the League of Nations and the Union of South Africa as mandatory power was entrusted, in terms of article 2 of the mandate, with "full power of administration and legislation over the territory subject to the present mandate as an integral portion of the Union of South Africa, and may apply the Laws of the Union of South Africa to the territory" subject to such local modifications as circumstances may require".⁴

The first administrator, E.H.L. Gorges, was appointed in November 1915 (while the country was still under martial law).⁵ He was responsible for the administration of the country under powers delegated to him by the Governor-General of the Union of South Africa in terms of Act 49 of 1919. The Administrator aso acted as chief Native Affairs Commissioner.⁶ In practice, this duty was delegated to the Secretary for South West Africa.

The South West Africa Constitution Act (Act 42 of 1925) provided for an elected Legislative Assembly, an Executive Committee consisting of the Administrator and four members of the Legislative Assembly and an Advisory Council consisting of the Executive Committee and three others.⁷

Act 42 of 1925 empowered the Legislative Assembly to legislate on various matters, but certain aspects were excluded. These were Defence, Native Affairs, Mining, Railways and Harbours, the Public Service, Posts and Telegraphs, Immigration, Customs and Excise and Banking control.⁸

Act 56 of 1954 (South West Africa Native Affairs Administration Act) transferred the administration of Native Affairs in South West Africa from the Chief Native Affairs Commissioner to the South African Department of Native Affairs. This Act come into operation on 1 April 1955. 10

The Secretary for South West Africa was the appointed Chief Executive Officer of the Administration of South West Africa and as such was in charge of the day to day administration of the country.

The following officials were appointed and served as Secretary for South West Africa between 1915 and 1959.¹¹

B. The Documents and their Arrangement

The archives of the Secretary for South West Africa are a continuation of the Archives of the Secretary of the Protectorate (ADM, finding aid 1/1/45). A new filing system was introduced in ca. 1920 which reflects the activities of the Secretary for South West Africa between 1920 and ca. 1959 when another new filing system (the A-S series) was introduced. The documents reflect the activities of all branches of the Administation but at various times certain branches established and used their own filing systems, e.g. the Education Branch (EDU, finding aid 1/1/61), the Lands Branch (LAN, finding aid 1/1/88). However the Secretary for South West Africa retained some control over the activities of the various branches and this is reflected in the documents.

The documents of the Secretary for South West Africa have been arranged in five main groups:

- I. Correspondence
- II. Circulars
- III. Indices,
- IV. Registers
- V. Statistical tables.

I. Correspondence

a) Registered correspondence

(i) A-series

This is the largest series of correspondence files and reflects a wide range of subjects covering the yeneral administration of the country during the period ca. 1920-1959. However some files date from 1915 having been taken over from the filing system used by the Secretary for the Protectorate 1915-1920 (ADM, finding aid 1/1/45). Some of these files were renumbered to fit in with the A-series while others were allocated an "A" before the file number. A small percentage of files extend beyond 1959.

The A-series made provision for 851 main subject headings, many of which were open numbers i.e. no subjects were ever allocated to these numbers. There is a frequent duplication of subjects because officials were not always fully acquainted with the working of the filing system.

The individual files are listed in twelve find-aid volumes. A list of main subject headings together with computer print-out numbers is included in this inventory.

(ii) Confidential correspondence

The W-, W/-, CC- and GL-series were used at various times to file correspondence considered to be of a confidential nature such as reports on certain persons, political activities, complaints against officials, agreements on land concessions, missionary activities and emergency measures.

The CC-series contains many instances where the same file number was used twice - when a file was closed its number was allocated to a new subject.

In some cases whole files originally bearing A-numbers were renumbered to fit in with CC-series. This has resulted in some volumes of a particular file being in the A-series while others are in the CC-series. Where this has occurred it has been indicated in the inventory by means of footnotes.

b) Unregistered correspondence and papers

i) Telegrams

This series consists of telegram books arranged chronologically according to series number - C series, M series, P series, H series and unnumbered telegrams. Some telegrams sent by the Private Secretary to the Administrator and by various commissions of enquiry are also included in this series.

ii) Papers and correspondence

This series has been arranged alphabetically according to subject.

The items in this series include correspondence, minutes of meetings, reports and memoranda, returns, lists, resolutions and completed forms covering a wide variety of subjects. In the inventory footnotes indicate the whereabouts of related material.

II. Circulars

The Secretary for South West Africa (Secretary for the Protectorate) issued a numerical series of circulars beginning in 1915 and extending to 1950. It has been decided to preserve these circulars as a unit, thus circulars from 1915 - 1920 have been included in this group.

In addition to the numerical series of circulars issued, unnumbered circulars, circular minutes, general minutes and staff circulars were issued. These circulars have been arranged according to year of issue and contain information on a wide variety of subjects. The majority of these circulars may also be found on the relevant subject files in the A-series of registered correspondence.

After 1950 a new system of numbering circulars was introduced - each year's circulars began from no.1. The circulars series extends beyond 1959 but is incomplete.

In addition to the circulars issued by the Secretary for South West Africa various departments issued their own circulars under the authority of the Secretary. These include the Director of Posts and Telegraphs, Justice Branch, the Master of the High Court, the Chief Native Affairs Commissioner, Prisons Branch and Revenue Branch.

Although as a general rule circulars received by an office and kept outside a filing system are not preserved it has been decided to preserve circulars received from the South African Chief Control Officer and the South African Treasury because these have research value and there is some doubt as to whether all these have been preserved on the relevant subject files in the A-series of registered correspondence.

III. Indices

For some of the larger main series of the A-series of registered correspondence files, the registry staff compiled index cards and books to facilitate the tracing of files. Most of these sets of index cards are incomplete but there is one major exception. A set of index cards for the more than 5,400 files of the A.820 "Hostile, suspect and dangerous persons" was created and preserved. This set of index cards is a useful and quick finding aid.

Index books exist for files in the A68/5/- "Immigration Permits" and the A.830 "Price Control" series.

IV. Registers

This series consists of correspondence registers, financial ledgers and registers (including a separate sub-series on the Angola-Boers), registers of import permits issued and health registers.

V. Statistical Tables

This series consists of tables compiled mainly for use in the Annual Reports on the Administration of South West Africa which were submitted to the Permanent Mandates Commission of the League of Nations. The statistics include vital statistics i.e. births, deaths, marriages and migration, trade, agriculture, native population and wages.

The documents have been appraised and certain ephemeral items have been destroyed in terms of the following disposal authorities: 081-B15 of October 1982, 018-B5/83 of July 1983, 081-B5/88 of May 1985 and 081-S.7 of July 1905.

Technical information

a) Storage

The Archives of the Secretary for South West Africa occupy 269 linear metre shelving space and consist of 3110 storage units (standard archival boxes). The items are usually in good physical condition, although the flimsy and acidic carbon-copy paper is occasionally in poor condition. Much damage has been done to frequently used files by repeated photocopying.

b) Data processing

The registered correspondence files had been included in the STATUS data base to enable information retrieval via a computer terminal. The STATUS database was maintained by the National Archives of South Africa. The data captured before Namibian indeependence is still accessible online ind the South African STAIRS database.

The data was downloaded for local maintenance in 1992, and converted to CDS/ISIS software in 1996. Further data covering the rest of the material was added after 2002. The data is accessible on the database FILES and the joint database NAN.

c) Digitisation

A few frequently consulted files whose preservation was endangered have been digitised. The originals of digitised files are withdrawn from consultation. The digitisation is noted in the database, and recorded in the printed finding aid at the status of December 2018.
