# Introduction

The magisterial district Grootfontein was established in 1916 by the military administration of the former German South West Africa by the Union Defence Force of South Africa. It was administered at first by military magistrates, and later by civil magistrates when a civil administration under the League of Nations Mandate was established.

The Magistrates were not only responsible for adjudicating criminal and civil cases, but also for a variety of administrative tasks, including “native administration”, registration of births, deaths and marriages, trade licensing, etc. Birth, death and marriage records are however not present in these records. They are only available at the Ministry of Home Affairs.

This findaid covers only the criminal case records 1916-1950, and the civil case records 1920-1964. It is obvious from the gaps in the numbering that the records have been appraised. While writing this preliminary introduction, it has not yet been researched according to which criteria the appraisal has been done.

There are substantially more records from the Magistrate Grootfontein present at the National Archives:

- A handwritten findaid 1/2/4 A exists for the Preliminary Examinations 1921-1938.
- A typed findaid 1/2/4 B exists for the correspondence files, including Native Affairs, 1916-1962, and is in the process of being registered in the database COURT.
- Case files 1969-1989, including the Regional Court and the Periodical Courts Kalkfeld and Okakarara, are available sorted and boxed but not listed.
- Court record books are available but not listed.
- Case records 1990ff. have been transferred in 2010 but are entirely unprocessed.

The processed collection is open for consultation without restrictions.
